## 1 Purpose

The following procedure contains details of the licensing/authorisation status of UGLRL CRN (CRN) signalling personnel and non-CRN signalling personnel (when engaged by CRN from time to time) to certify signalling infrastructure and systems fit for purpose, in the testing, commissioning, de-commissioning and/or maintenance phases of its life-cycle. Also included is the list of Authorised Officers approved to conduct Signal Licensing Board assessment/examination for the signalling discipline.

This document also lists the signalling personnel who are accredited to carry out the initial set-up, programming, test and commissioning of Cerberus level crossing monitors.

This document is to be considered an active document that will be updated regularly as a person's status changes or new personnel are added, or others removed from the various lists.

#### 1.1.6 Signals Authorised Person

**CRN Authorised Signalling Personnel:** The list shows details of CRN signalling persons who are not licensed but are authorised to perform prescribed signalling works in live signalling locations as detailed by their individual Statement of Competency.

**Non-CRN Authorised Signalling Personnel:** The list shows details of non-CRN signalling persons who are not licensed but are authorised to perform prescribed signalling works in live signalling locations as detailed by their individual Statement of Competency.

Approved Signalling Personnel accredited for Set to Work, Test and Certification of Track Circuits: The list shows details of approved signalling personnel accredited to undertake initial set-up, test and certification of track circuits – limited to track circuit types as identified.

Approved Signalling Personnel accredited for Programming, Test and Commissioning of Cerberus Level Crossing Monitors: The list shows details of approved signalling personnel accredited to undertake programming, test and commissioning of Cerberus level crossing monitors.

#### 1.2 CRN Signal Engineer - Authorised Officers (Licensing Board)

**CRN Signal Engineer - Authorised Officers (Licensing Board):** The list details the Signal Engineer's Licensing Board level status to conduct signalling licensing examination/assessment for the discipline.

#### 1.3 Currency

A current Signalling Licence or Authorisation is valid for three (3) years from the date shown in this document or to the next scheduled general reaccreditation.

#### 1.4 Inclusion and Amendments to Approved Lists

Licensed Signal Engineers, Signal Electricians, Signal Mechanical, Signals Interlocking Fitter, Signals Design or Signals Authorised Persons, including non-CRN signalling personnel, are included in the appropriate list as they become eligible through obtaining the relevant signalling safeworking licence/authorisation and maintaining that licence through re-assessment and engagement or continued employment within the CRN.

A person holding a current CRN licence for Signal Engineer, Signal Electrical, Signal Mechanical, Signals Interlocking Fitter, Signals Design or Signals Authorised Person, not listed, and wishing to be included on the Approved Listings, or a licensed Signal Engineer wishing to be elevated in the





CRN's Authorised Officers List for Licensing Boards, may make written application to the Principal Signal & Communications & Network Control Engineer. Consideration will be given to the applicant's currency, merits and experience, and if satisfactory, the amendment shall be approved.

Suitable persons wishing to be included or updated on the listings for programming, test and commissioning of Cerberus level crossing monitors may make written application to the Principal Signal & Communications & Network Control Engineer.

Where applicable the application must include the recommendations of the required authorised officers as stipulated in CRN ST 002.

#### 2 Approved Listings

Accreditation expiry dates are shown for all current listings.

Expired Statements of Competency information may remain published for a short period between periodic updates.

Any expired listings published will be removed from the list following the most recent update.
